

This Pricelist is applicable for the following services: **Novera Telephone Connection, Novera Komplet, Novera Komplet Office, Novera Telephone Selection, Novera Telephone Pre-Selection, Novera IP Komplet, Novera Komplet Pro, Novera Duo Garant and Novera duo expres.**

These services are charged according to:

- a) Pricelist of particular service (no applies to Novera Telephone Connection, Novera Telephone Pre-selection and Novera Telephone Selection)
- b) Respective pricing programme
- c) This Pricelist of publicly available telephone services

In case of discrepancies in statements in particular documents, the legal priority is set by above mentioned pricing documents order and the prices shall be governed thereby.

## 1 Minimum term of service use

- 1.1 Minimum term of the Novera Telephone Connection, Novera Komplet, Novera Komplet Office, Novera Telephone Selection, Novera Telephone Pre-Selection, Novera IP Komplet, Novera Komplet Pro, Novera Duo Garant and Novera duo expres.

The minimum term for which the Subscriber must use the service is twelve (12) calendar months from the service setup date.

A longer minimum term may be stipulated in the respective Service Specification.

## 2 Fees and Charges

- 2.1 Types of fees for the Novera Telephone Connection service

Setups, relocations and modifications of the Novera Telephone Service (non-recurrent fees) are charged according to Article 3.

Operation of the Novera Telephone Service is charged with a regular monthly fee According to Article 4 and operational fee, or minimum operational fee according to Articles 5 a 6.

- 2.2 Types of fees for the Novera Telephone Selection and Pre-Selection services

Setups and relocations of the Novera Telephone Selection and Pre-Selection services are free of charge. Modifications of the Novera Telephone Selection and Pre-Selection service settings are charged according to Article 3.4.

Operation of the Novera Telephone Selection and Pre-Selection services is charged with a regular monthly fee according to the respective pricing programme, or the minimum operational fee according to Articles 5 and 6. The Subscriber is charged for all calls via the GTS NOVERA network.

- 2.3 Types of fees for the Novera Komplet service

Setups, relocations and modifications of the Novera Komplet service are charged with non-recurrent fees according to the Pricelist of Novera Komplet Office service and according to Articles 3.3 and 3.5.

Operation of the Novera Komplet service is charged with a regular monthly fee according to the Pricelist of the Novera Komplet service and according to Article 4.2, and also the operational fee according to the respective pricing programme and according to Article 5 or minimum operational fee according to the Pricelist of the Novera Komplet service.

- 2.4 Types of fees for the Novera Komplet Office service

Setups, relocations and modifications of the Novera Komplet Office service are charged with non-recurrent fees according to the Pricelist of Novera Komplet Office service and according to Articles 3.3 and 3.5.

Operation of the Novera Komplet Office service is charged with a regular monthly fee according to the Pricelist of the Novera Komplet Office service and according to Article 4.2, and also the operational fee according to the respective pricing programme and according to Article 5 or minimum operational fee according to the Pricelist of the Novera Komplet Office service.

- 2.5 Types of fees for the Novera IP Komplet service

Setups, relocations and modifications of the Novera IP Komplet service are charged with non-recurrent fees according to Pricelist of the Novera IP Komplet service and according to Article 3.5.

Operation of the Novera IP Komplet service is charged with a regular monthly fee according to the Novera IP Komplet Service Specification and according to Article 4.2, and also the operational fee according to the respective pricing programme and according to Article 5 or minimum operational fee according to Novera IP Komplet Service Specification.

Valid from 1.6. 2008. The prices in this Pricelist are stated in CZK excl. 19% VAT.

## 2.6 Types of fees for the Novera Komplet Pro service

Setups, relocations and modifications of the Novera Komplet Pro service are charged with non-recurrent fees according to the Pricelist of Novera Komplet Pro service and according to Articles 3.3 and 3.5.

Operation of the Novera Komplet Pro service is charged with a regular monthly fee according to the Pricelist of the Novera Komplet Pro service and according to Article 4.2, and also the operational fee according to the respective pricing programme and according to Article 5 or minimum operational fee according to the Pricelist of the Novera Komplet Pro service.

## 2.7 Types of fees for the Novera Duo Garant service

Setups, relocations and modifications of the Novera Duo Garant service are charged with non-recurrent fees according to Pricelist of Novera Duo Garant service.

Operation of the Novera duo garant service is charged with a regular monthly fee according to the Pricelist of Novera Duo Garant service and according to Article 4.2, and also the operational fee according to the respective pricing programme and according to Article 5 or minimum operational fee according to Pricelist of Novera Duo Garant service.

## 2.8 Types of fees for the Novera duo expres services

Setups, relocations and modifications of the Novera duo expres service are charged with non-recurrent fees according to Pricelist of Novera Duo Garant service.

Operation of the Novera duo expres is charged with a regular monthly fee according to the Pricelist of Novera Duo Garant service and according to Article 4.2, and also the operational fee according to the respective pricing programme and according to Article 5 or minimum operational fee according to Pricelist of Novera Duo Garant service.

Maturity of the non-tax part of the invoice is equal to the maturity of the invoice for telecommunication services provided by GTS Novera.

The partner (service provider) is obliged to issue a tax document per request and pay VAT. The contractual partner is obliged to issue due tax document to GTS Novera subscribers upon submission of the non-tax payment document from GTS Novera for the provided services and information.

The minimum operational fee for each individual locality of the Subscriber is, in the respective accounting period, determined as a sum of minimum operational fees for all connection types (HTS, euroISDN BRI, euroISDN BRI U, euroISDN PRI 8, PRI 10, PRI 15, PRI 16, PRI 30 or E1(CAS)), first multiplied by the number of the respective-type connections in each individual Locality of the Subscriber according to the relevant Service Specification.
