This price list contains discounted prices for establishment and operation of GTS duo expres service and for end device sale. Minimum period of use of GTS duo expres service by the participant is twelve (12) or eighteen (18) months from the day of establishment of the GTS duo expres service. In case the participant does not keep the defined minimum period of used, the participant will be additionally charged the standard one-off prices according to point 1.1 and the standard sale prices according to point 3 of this price list up to full amount and further the one-off price according to the relevant provisions of General Conditions of Provision of Publicly Accessible Service of Electronic Communications.

1.3 Fees for Phone Calls

1.4 Minimum price for operation
